1. All Posts are purely temporary and created for the specific period of four months (120 days) under section 9(2)(e)(i) of the Maharashtra University of Health Sciences, Act 1998 from the University Fund on contract fix pay basis.
2. Being temporary contractual posts, the person appointed on such posts shall not be entitled for retirement or any other benefits applicable to the permanent employees and also not entitled to claim any rights, interest, benefits or equity of the permanent service either in the University fund post or Government sanctioned post.
3. The selected candidates shall be initially given appointment on the post for the period of four months (120 days) purely temporary basis or till the regular Five years continuation posts are to be filled by MPGI, MUHS, Nashik whichever is earlier.
4. If the candidate appointed on temporary basis desire to resign, he/she must submit resignation with a notice of one month in advance. 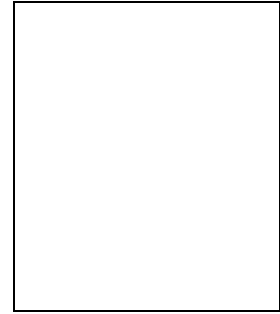
